6.7 Addition: PETITION BY THE CITY OF ROSEMÈRE REGARDING CANADA POST'S DECISION TO ELIMINATE DOOR-TO-DOOR DELIVERY

CONSIDERING that Canada Post has decided to eliminate door-to-door delivery in all Canadian cities and replace it with community mail box (CMB) delivery;

CONSIDERING that Canada Post made this decision unilaterally;

CONSIDERING that this decision will take effect in the fall of 2014 in the cities of Bois-des-Filion, Lorraine and Rosemère;

CONSIDERING that Canada Post is a Crown corporation whose mandate is to provide and maintain a quality public postal delivery service;

CONSIDERING that Canada Post's decision represents a major reduction in the quality of service the people of Rosemère have the right to expect;

CONSIDERING that the City of Rosemère has the primary responsibility for land development and management, but was not consulted by Canada Post prior to this decision being made, having received notice on the eve of the public notice by press release;

CONSIDERING that the City of Rosemère has already advised Canada Post that land use is not designed to accommodate such CMBs;

ACCORDINGLY,

It is moved by Mayor Madeleine Leduc and seconded by Councillor Normand Corriveau, and unanimously

RESOLVED:

- to oppose Canada Post's decision to eliminate door-to-door delivery and replace it with CMBs;
- to ask Canada Post to suspend its decision;
- to encourage Canada Post and the Canadian government to reconsider their postal policy and maintain a quality service involving the traditional door-to-door delivery in urban areas;
- to send a copy of this resolution to the Chairman of the Canada Post Board of Directors, to the President and Chief Executive Officer of Canada Post, to the Group President Physical Delivery Network, Canada Post, to the minister responsible for the Canada Post Corporation, to MP Alain Giguère, to the Union des municipalités du Québec (Quebec Federation of Municipalities), as well as the Canadian Federation of Municipalities.
