MONDAY, MAY 13, 2019

Morning Session

OPENING CEREMONIES

The CUPW National Convention was called to order at 9:00h.

Brother Mike Palecek, National President, introduced himself and welcomed the delegates to Toronto and to the 26th CUPW National Convention. The members sang “Solidarity Forever”.

Brother Palecek introduced Brother Sanjay Sapra, National Director, Metro-Toronto Region, and Sister Megan Whitfield, President of the Toronto Local.

Brother Sapra and Sister Whitfield welcomed delegates, observers and guests to Toronto.

INDIGENOUS WELCOME CEREMONY AND SMUDGE

Following the opening ceremonies, Brother Palecek introduced Sister Crystal Sinclair, Indigenous Rights activist and member of OPSEU, and Brother Ron Rousseau, President of the Whitehorse Local, President of the Yukon Federation of Labour and the Indigenous Vice-President of the Canadian Labour Congress. They will perform the smudge ceremony.

Sister Sinclair greeted the delegates, wishing them good conversations, respect, compassion, listening and good communication. Brother Rousseau explained the purpose of the smudging and proceeded to smudge the room while Sister Sinclair described the smudging and performed the Cherokee Morning song on the drum.

Brother Palecek introduced the members of the National Executive Board.

WELCOME TO TORONTO BY CHRIS BUCKLEY

Brother Palecek introduced the President of the Ontario Federation of Labour, Brother Chris Buckley. Brother Buckley is a lifelong trade unionist and social justice advocate. He is the former President of Unifor Local 222 in Oshawa and the Chair of the Master Bargaining Committee. He was unanimously elected as the President of the Ontario Federation of Labour in 2015. Brother Buckley addressed the convention floor.

WELCOME TO TORONTO BY JOHN CARTWRIGHT

Brother Palecek introduced Brother John Cartwright. Brother Cartwright is the President of the Toronto and York Region Labour Council, sits on the National Board of the Council of Canadians. Brother Cartwright was a carpenter by trade and was first elected as Union Representative in 1982. Brother Cartwright addressed the convention floor.

ANTI-HARASSMENT POLICY

Brother Tim Armstrong, National Director, Pacific Region was assigned as the Officer to the Anti-Harassment Committee. He introduced its members: Sister Jessica Dempster, Pacific Region; Sister Maddie Cleroux-Abbas, Central Region; Brother Vincent Lambert, Quebec Region and Sister Megan Whitfield, Metro-Toronto Region.

Sister Jan Simpson, 1st National Vice-President along with all committee members read the anti-harassment policy.

MEMORIAL

Everyone in the convention hall rose in a moment of silence in memory of all the Sisters, Brothers and Cousins who have died since the last National Convention and whose names are scrolling on the video.

PRESIDENTIAL ADDRESS

Sister Simpson introduced Brother Palecek, National President, for his presidential address.

CREDENTIALS COMMITTEE REPORT

Brother Gislain Gagné and Sister Darlene Steele of the Credentials Committee presented the report of all accredited delegates.

There were a total 575 delegates and 83 observers: 297 Sisters, 361 Brothers and 6 Cousins, 575 from the Urban Operations, 87 from the RSMCs and 2 from the private sector bargaining units.

It is MOVED by Brother Gagné of the Credentials Committee and SECONDED by an unidentified delegate and CARRIED UNANIMOUSLY to adopt the report of the Credentials Committee.

NATIONAL EXECUTIVE BOARD REPORT

The Chair opened the floor for debate on the report of the National Executive Board.

The Convention meeting adjourned for lunch at 13:05h.

TUESDAY, MAY 14, 2019

Morning Session

The meeting convened at 9:20h.

CREDENTIALS COMMITTEE REPORT

Brother Gagné and Sister Steele of the Credentials Committee presented the amended Credentials Committee report of Tuesday, May 14, 2019 as follows: a total of 659 delegates, 575 registered, 297 women delegates, 361 male delegates, 6 non-binary delegates; 575 from the Urban Operations, 87 from the RSMCs and 2 from the private sector and 83 registered observers.

It is MOVED by Brother Gagné of the Credentials Committee, SECONDED by an unidentified delegate, and CARRIED UNANIMOUSLY to adopt the report of the Credentials Committee.

ACTION PLAN

Brother Floresco, 3rd National Vice-President, summarized and highlighted points of the Action Plan.

The Chair opened the floor for debate on the Action Plan.

It is MOVED by Brother Palecek, National President, SECONDED by Sister Simpson, 1st National Vice-President and CARRIED to adopt the Action Plan for the next CUPW mandate.

CONSTITUTION COMMITTEE

The Constitution Committee elected Sister Bev Ray of the Regina Local and Brother Brahm Enslin of the Saskatoon Local, as Chair and Secretary of the Constitution Committee respectively.

Sister Ray read the list of the first five priorities to be addressed by the convention delegates.

RESOLUTION NO. 16

Brother Enslin, Secretary of the Constitution Committee read:

“The Committee unanimously recommends adoption of resolution no. 16.

BE IT RESOLVED that resolutions be the primary focus of Convention, and that at least 70% of the time allotted for Convention, excluding the day of elections be exclusively devoted to debating and voting on resolutions.”

Sister Ray, Chair of the Constitution Committee, provided the rationale.

The Chair opened the floor for debate.

Following the debate, the question was called.

The delegates voted in favour of adopting resolution no. 16.

COMPOSITE RESOLUTION NO. 3 TO COVER THE INTENT OF RESOLUTIONS NOS. 181, 182 AND 184

Brother Enslin, Secretary of the Constitution Committee, read:

“The Committee unanimously recommends adoption of composite resolution no. 3 to cover the intent of resolutions nos. 181, 182 and 184.

BE IT RESOLVED that the National Executive Board first turn to CUPW members in good standing, by informing them of available positions through a posting, to work on any project or campaign of the Union;

And that no specialists be hired when our members have or can acquire the specific expertise for such projects or campaigns.”

Sister Ray, Chair of the Constitution Committee, provided the rationale.

The Chair opened the floor for debate.

It is MOVED by Brother Hentzelt, Edmonton Local, SECONDED by Sister Theakston, Toronto Local, and DEFEATED to refer back composite resolution no. 3 to the Committee for modification, with instruction to remove the words “or can acquire”.

Delegates resumed the debate on the original composite resolution no.3.

The Convention adjourned for lunch at 13:00h.

TUESDAY, MAY 14, 2019

Afternoon Session

The meeting reconvened at 14:45h.

CONSTITUTION COMMITTEE

The floor resumed the debate on composite resolution no. 3.

After deliberation, the question was called by Brother Chaloux, Montreal Local, SECONDED by an unidentified delegate, and CARRIED.

The Chair asked the delegates if they were in favour or against the adoption of composite resolution no. 3.

The delegates voted to reject composite resolution no. 3.

RESOLUTION NO. 185 TO COVER THE INTENT OF RESOLUTION NOS. 34 AND 185

Brother Enslin, Secretary of the Constitution Committee, read:

“The Committee unanimously recommends adoption of resolution no. 185.

THEREFORE BE IT RESOLVED at the start of all new mandates, appointed positions need to be advertised to the entire membership so that all members have an opportunity to apply. There will be an application process and the newly elected National Executive Board will review all applications. The Officers responsible for the appointees must submit a semi-annual written report to the National Executive Board on the work the appointees have performed during the mandate;

THEREFORE BE IT FURTHER RESOLVED that the work being done will be reviewed by the National Executive Board on a semi-annual basis to determine whether or not said appointments shall be renewed;

THEREFORE BE IT FINALLY RESOLVED that the Officers responsible for the appointees must also submit a full written report at National Convention of the work they have accomplished.”

Sister Ray, Chair of the Constitution Committee, provided the rationale.

The Chair opened the floor for debate.

Following discussion, the question was called by Sister Dagenais, Montreal Local, SECONDED by an unidentified delegate and DEFEATED.

Is it MOVED by Brother Stenson, Kitimat Local, SECONDED by Brother MacKenzie, Windsor Local, and CARRIED to refer back composite resolution no. 185 to the Constitution Committee to remove from the English version and corrected to say “the appointees”.

While the Constitution Committee is away deliberating on the referral of resolution 185, the Chair took the opportunity to read the letter from Brother Mark Dimondstein, President of the American Postal Workers Union on his solidarity greeting on behalf of the 200,000 members of the APWU.

Following the referral, Sister Ray explained that the Constitution Committee met to discuss the motion of reconsideration of resolution no. 185, which now reads as follows:

“THEREFORE BE IT RESOLVED at the start of all new mandates, appointed positions need to be advertised to the entire membership so that all members have an opportunity to apply. There will be an application process and the newly elected National Executive Board will review all applications. The Officers responsible for the appointees must submit a semi-annual written report to the National Executive Board on the work the appointees have performed during the mandate;

THEREFORE BE IT FURTHER RESOLVED that the work being done will be reviewed by the National Executive Board on a semi-annual basis to determine whether or not said appointments shall be renewed;

THEREFORE BE IT FINALLY RESOLVED that the Officers responsible for the appointees must also submit a full written report at National Convention of the work these members have accomplished.”

Sister Ray, Chair of the Constitution Committee, provided the rationale and indicated the vote was unanimous.

The Chair asked delegates if they were in favour or against the adoption of resolution no. 185, as amended.

The delegates voted in favour of adopting resolution no. 185 as amended.

RESOLUTION NO. 133

Brother Enslin, Secretary of the Constitution Committee, read:

“The Committee recommends adoption of resolution no. 133.

BE IT RESOLVED section 7.48 be amended to add member(s) that are working for the Union on a temporary basis.

BE IT FURTHER RESOLVED that the allowance in 7.49 will be fifty percent (50%) of the meal per diem rates found in section 7.42.

BE IT FINALLY RESOLVED if the members are authorized to attend or participate in other Union activities during the same period that the per diem in section 7.42 will apply to those times.”

Sister Ray, Chair of the Constitution Committee, provided the rationale.

Following the debate, the Chair asked delegates if they were in favour or against the adoption of resolution no. 133.

The delegates voted in favour of adopting resolution no. 133.

RESOLUTION NO. 126 TO COVER THE INTENT OF RESOLUTION NOS. 117 AND 121

Brother Enslin, Secretary of the Constitution Committee, read:

“The Committee recommends adoption of resolution no. 126.

BE IT RESOLVED that allowances for daily per diems will be increased July 1, 2020 as follows:

• <i>Breakfast</i>	\$ 18.00
• <i>Lunch</i>	\$ 20.00
• <i>Dinner</i>	\$ 34.00

THEREFORE BE IT FINALLY RESOLVED that these amounts will be adjusted yearly as per the provision of section 7.62 of the Constitution.”

Sister Ray, Chair of the Constitution Committee, provided the rationale.

The Chair opened the floor for debate.

Following the debate, the Chair asked the delegates if they were in favour or against the adoption of resolution no. 126.

The delegates voted in favour of adopting resolution no. 126.

RESOLUTION NO. 127 TO COVER THE INTENT OF RESOLUTION NO. 120

Brother Enslin, Secretary of the Constitution Committee, read:

“The Committee unanimously recommends adoption of resolution no. 127.

THEREFORE BE IT RESOLVED that the per diem set out in section 7.42 shall be reviewed by the National Secretary-Treasurer and the Director of Finance prior to the departure. These per diems shall be reimbursed at a rate equal to that country’s currency, taking into consideration the location of the events and availability of meals.”

Sister Ray, Chair of the Constitution Committee, provided the rationale.

The Chair opened the floor for debate.

Following the debate, the Chair asked the delegates if they were in favour or against the adoption of resolution no. 127.

The delegates voted in favour of adopting resolution no. 127.

RESOLUTION NO. 53

Brother Enslin, Secretary of the Constitution Committee, read:

“The Committee recommends adoption of resolution no. 53.

THEREFORE BE IT RESOLVED to combine the duties of the 2nd and 3rd National Vice-President positions into one position;

BE IT FURTHER RESOLVED that this position be called the 2nd National Vice-President;

BE IT FURTHER RESOLVED that the 4th National Vice-President position becomes the 3rd National Vice-President;

BE IT FINALLY RESOLVED that the communication portion and labour movement duties of the 3rd National Vice-President shall be moved to the 1st National Vice-President duties.”

Sister Ray, Chair of the Constitution Committee, provided the rationale.

The Chair opened the floor for debate.

Following discussions, the question was called by Brother Lawrence, Oshawa Local, SECONDED by Sister McKinnon, Fraser Valley West Local, and CARRIED.

The Chair asked the delegates if they were in favour or against the adoption resolution no. 53.

The delegates voted to reject resolution no. 53.

RESOLUTION NO. 162 TO COVER THE INTENT OF RESOLUTION NO. 163A

Brother Enslin, Secretary of the Constitution Committee read:

“The Committee recommends adoption of resolution no. 162 to cover resolution no. 163a).

BE IT RESOLVED section 10.01 of the National Constitution be amended to remove one National Union Representative and to combine the duties of the second and third paragraphs to read:

One National Union Representative works in the grievance-arbitration section in conjunction with the National Grievance Officer to deal primarily with Health and Safety, Workers compensation, benefit plans, employment insurance, pension and consultation with employers”.

Sister Ray, Chair of the Constitution Committee, provided the rationale.

The Chair opened the floor for debate.

After deliberation, the question was called by the Chair and CARRIED.

The Chair asked the delegates if they were in favour or against the adoption of resolution no. 162.

The delegates voted to reject resolution no. 162.

RESOLUTION NO. 156

Brother Enslin, Secretary of the Constitution Committee, read:

“The Committee unanimously recommends adoption of resolution no. 156.

BE IT RESOLVED to delete the word “telegram” and replace it with “Internet.”

Sister Ray, Chair of the Constitution Committee, provided the rationale.

The Chair asked the delegates if they were in favour or against the adoption of resolution no. 156.

The delegates voted in favour of adopting resolution no. 156.

The Convention adjourned at 16:50h for recess and reconvened at 17:05h.

SOCIAL STEWARD PRESENTATION

Sister Simpson introduced Brother Denis Lemelin, National Union Representative under the direction of the National Executive Committee, and Brother Yves Hénault, National Union Representative of Education (French).

Brother Hénault recognized the presence of 114 social stewards and thanked them for the work they perform. A video about social stewards followed.

A quick history of the work of social stewards and their ongoing goals was provided to the delegates.

The Chair opened the floor for questions and comments.

CONSTITUTION COMMITTEE

Sister Ray, Chair of the Constitution Committee, explained that the Committee met briefly before taking the stage and accepted a referral to change the priority of resolution no. 64.

RESOLUTION NO. 64

Brother Enslin, Secretary of the Constitution Committee read:

“The Committee unanimously recommends adoption of resolution no. 64.

BE IT RESOLVED that a social stewards’ conference be organized in each region every four (4) years and that the funds needed to hold these meetings be paid out of the Union’s General Fund.”

The Chair opened the floor for debate.

After deliberations, the Chair asked the delegates if they were in favour or against the adoption of resolution no. 64.

The delegates voted unanimously in favour of adopting resolution no. 64.

RESOLUTION NO. 135

Brother Enslin, Secretary of the Constitution Committee, read:

“The Committee unanimously recommends adoption of resolution no. 135.

THEREFORE BE IT RESOLVED that 7.50 be revised to remove “for a period of 30 minutes per week” from the paragraph:

“Where applicable, members of a negotiating committee shall receive a return transportation ticket to their place of residence once every three weeks and may use National Office telephones to contact their family. Any time spent travelling by negotiators to their home for the visit shall be deemed as work time.”

Sister Ray, Chair of the Constitution Committee, provided the rationale.

The Chair opened the floor for debate.

Following discussion, the Chair asked the delegates if they were in favour or against the adoption of resolution no. 135.

The delegates voted unanimously in favour of adopting resolution no. 135.

RESOLUTION NO. 137

Brother Enslin, Secretary of the Constitution Committee, read:

“The Committee recommends adoption of resolution no. 137.

BE IT RESOLVED to include the RSMC unit in section 7.60.”

Sister Ray, Chair of the Constitution Committee, provided the rationale.

The Chair opened the floor for debate.

Following discussions, the Chair asked the delegates if they were in favour or against the adoption of resolution no. 137.

The delegates voted unanimously in favour of adopting resolution no. 137.

RESOLUTION NO. 81 TO COVER THE INTENT OF RESOLUTION NO. 79

Brother Enslin, Secretary of the Constitution Committee, read:

“The Committee unanimously recommends adoption of resolution no. 81.

WE WANT section 6.03 to read:

Sections 6.04 to 6.21 and 7.48 to 7.51 apply only to the Urban Postal Operations and the Rural and Suburban Mail Carriers bargaining units. In cases of the...”

Sister Ray, Chair of the Constitution Committee, provided the rationale.

The Chair opened the floor for debate.

Following discussions, the Chair asked the delegates if they were in favour or against the adoption of resolution no. 81 to cover the intent of resolution no. 79.

The delegates voted in favour of adopting resolution no. 81.

The Convention adjourned at 18:28h for supper.

TUESDAY, MAY 14, 2019

Evening Session

The meeting reconvened at 20:10h.

CONSTITUTION COMMITTEE

RESOLUTION NO. 20 TO COVER THE INTENT OF RESOLUTION NO. 47

Brother Enslin, Secretary of the Constitution Committee, read:

“The Committee recommends adoption of resolution no. 20.

THEREFORE BE IT RESOLVED that each Region shall have a Regional Work Measurement committee consisting of four (4) members elected plus the two (2) Regional members elected to the National Work Measurement committee.

BE IT FURTHER RESOLVED that these members will receive the appropriate training as soon as possible and will meet twice a mandate in a location that is most cost effective, with teleconferences taking place in between meetings.

BE IT FURTHER RESOLVED that these four (4) members will be elected at National Convention in the Regional caucuses until the next convention when they will be elected at the Regional Conference.

BE IT FINALLY RESOLVED the Local utilizing the services of these trained committee members will be responsible for all associated costs.”

Sister Ray, Chair of the Constitution Committee, provided the rationale.

The Chair opened the floor for debate.

It is MOVED by Brother Lapointe, Metro-Montreal Region, and SECONDED by Brother Gianfranco Sarro, Metro-Montreal Region, to refer back resolution no. 20 to cover the intent of resolution no. 47 to the Committee with instructions to strike out the word “elected” from the first BE IT RESOLVED and modify the before last BE IT FURTHER RESOLVED to read as follows:

BE IT FURTHER RESOLVED that these four (4) members will be elected at the pre-convention Regional Conference.

Brother Lemelin, National Union Representative under direction of NEC, challenged the motion. The Chair rules in favour of the challenge.

It is MOVED by Brother Lapointe, Metro-Montreal Region, and SECONDED by Sister Stéphanie Robinson, Metro-Montreal Region, to challenge the Chair.

Sister Simpson, 1st National Vice-President takes the Chair. Brothers Lapointe and Palecek present their arguments.

The Chair asked the delegates if they were in favour or against the Chair’s ruling. The delegates voted to uphold the Chair’s ruling.

Following discussions, the Chair called the question.

It is MOVED by Brother Dave Bleakney, 2nd National Vice-President, SECONDED by Sister Jan Simpson, 1st National Vice-President and CARRIED to allow four indigenous members enter the convention floor to perform a short presentation.

The indigenous members performed a presentation of “A Song and Dance”.

NATIONAL WOMEN’S COMMITTEE AND NATIONAL HUMAN RIGHTS COMMITTEE REPORTS

Sister Darly Aimé, National Human Rights Committee member and Sister Cathy Kennedy, National Women’s Committee, acknowledge the work of the National Women’s Committee and National Human Rights Committee members and alternates.

Sister Aimé introduced guest speakers, Rodney and Pascale Diverlus, cultural commentators and media contributors from Black Lives Matter.

Rodney and Pascale Diverlus touched upon many subjects that affect workplaces.

CONSTITUTION COMMITTEE

The Chair of the caucus shall be the highest ranking sister in the Regional Office, in attendance. If the situation occurs where sisters have the same ranking, the sister's seniority date shall determine the Chair of the caucus, if necessary.

If there are no sisters in the Regional Office, the Chair shall be the highest-ranking sister in a local executive position in attendance with the highest seniority not running for the National Women's Committee. Furthermore, the Chair of the Women's Caucus shall break any tie.”

Not to be included in the language, the intent of 'if necessary is if one sister chooses to not Chair.

The intent of “seniority” is the seniority defined in their respective collective agreements.

The intent of “highest-ranking local executive” is in the following order:

- *Local President;*
- *1st Vice-President;*
- *Secretary-Treasurer.”*

Sister Ray, Chair of the Constitution Committee, provided the rationale.

The Chair opened the floor for debate.

Following discussions, the Chair asked the delegates if they were in favour or against the adoption of resolution no. 36.

The delegates voted unanimously in favour of adopting resolution no. 36.

RESOLUTION NO. 38 TO COVER THE INTENT OF RESOLUTION NO. 37

“The Committee unanimously recommends adoption of resolution no. 38 to cover resolution 37.

THEREFORE BE IT RESOLVED that the phrase, “lesbians and gays and transgender people” in section 4.07 of the National Constitution be changed to: “lesbian, gay, bisexual, transgender and queer and/or LGBTQ”;

BE IT FURTHER RESOLVED that with the exception of Policies D-17 and D-18, all references to lesbian, gays, bisexual and transgender people be changed to “lesbian, gay, bisexual, transgender and queer and/or LGBTQ”.”

Sister Ray, Chair of the Constitution Committee, provided the rationale.

The Chair opened the floor for debate.

Following discussions, the Chair asked the delegates if they were in favour or against the adoption of resolution no. 38 to cover the intent of resolution 37.

The delegates voted unanimously in favour of adopting resolution no. 38 to cover the intent of resolution 37.

After deliberation, the question was called by Brother Lapointe, National Director, Metro-Montreal Region, SECONDED by Brother Jeff Callaghan, National Director, Atlantic Region and CARRIED.

The Chair asked the delegates if they were in favour or against the adoption resolution no. 161 to cover the intent of resolution no. 163B.

The delegates voted to reject resolution no. 161 to cover the intent of resolution no. 163B.

COMPOSITE NO. 2 TO COVER THE INTENT OF RESOLUTIONS NOS. 21 AND 72

It is MOVED by Sister Natalie Dias, Thompson Local, and SECONDED by Brother Connor Dowd-Taylor, Grande Prairie Local, to ask the Committee to respectfully stand down and return in five minutes and bring back composite resolution no.2 to the floor.

Sister Ray, Chair of the Constitution Committee, provided a point of information that during the Constitution Committee meeting at the lunch break, the motion of reconsideration to change the order of priority of composite resolution no. 2 was defeated.

Brother Lapointe, National Director, Metro-Montreal Region, motioned a point of order stating a reconsideration of a motion is non-debatable and must be voted on immediately.

Brother Lemelin, National Union Representative under direction of NEC, motioned a point of order stating there is no motion on the floor therefore there cannot be a motion of reconsideration.

The Chair ruled in favour of Brother Lemelin.

Sister Simpson, 1st National Vice-President, took the Chair.

It is MOVED by Sister Brandi Anderson, Grande Prairie Local, SECONDED by Brother Dustin Hill, Edmonton Local, to challenge the Chair.

Sister Anderson and Brother Palecek presented their arguments.

The Chair asked the delegates if they were in favour or against the Chair's ruling. The delegates voted against the Chair's ruling.

Brother Palecek, National President, took the Chair.

The Chair asked the delegates if they were in favour or against referring composite resolution no. 2 back to the Constitution Committee. The delegates voted in favour of referring the composite resolution back to the Constitution Committee.

The Convention floor was in recess to allow the Constitution Committee to discuss the motion of referral before them. Upon their return, Brother Enslin, Secretary of the Constitution Committee, read:

“The Committee recommends adoption of composite no. 2 to cover the intent of resolution nos. 21 and 72.

BE IT RESOLVED that a Youth Committee is recognized under Article 4 of the National Constitution.

BE IT RESOLVED that Regional Youth Committees shall study and make recommendations to the National Executive Board on:

- (a) the involvement of youth in the Union with the goal of full participation of young workers in all levels of the Union;*
- (b) the education of the membership on equality issues facing young workers;*
- (c) the situation of young workers in the workplace and ways to improve it.*

This committee shall be composed of youth members ensuring gender parity from each region. Members of the Youth Committee must be MIGS.

BE IT RESOLVED that these members will be elected at National Convention in the regional caucus until the next Convention, when they will be elected at Regional Conferences.

BE IT RESOLVED that, if no youth delegates are at Convention from a region, after Convention the region will send a notice to locals with an application form for youth member(s) to be selected as members on the Regional Youth Committee. If more than one member in a local applies to be part of the Regional Youth Committee, they shall be elected by the general membership. The Local will then send the application with a recommendation from the Local to the National Director. The Regional Executive Committee will review all application forms and select the representative on the Regional Youth Committee.

BE IT RESOLVED that the elected Regional Youth Committee members, with the assistance of the Regional Education and Organization Officer, will establish a Regional Youth Committee for members 30 years of age and younger at the time of election. Regardless of the members' age, they will remain as a member of the Youth Committee until the next Convention.

BE IT RESOLVED these Regional Youth Committees will communicate monthly by conference call to discuss young worker issues and create campaigns to encourage involvement in not only CUPW but in support of all Federations of Labour, FTQ/CLC Young Worker Committees.

BE IT FINALY RESOLVED that subject to the approval of the National Executive Board, National Directors shall be authorized to spend up to \$10,000 per fiscal year to reimburse delegates approved by their Local, to pay travel expenses, accommodation, per diem, registration fees, lost wages and childcare. This in order to assist CUPW youth participate in trade union education, conferences, seminars, forums and events sponsored by young worker organizations. The recommendation of the National Director shall take into consideration the financial status of the Local and the need to increase the level of young workers participation.

All monies not spent from the new section 7.60 shall be reinvested in the regions to assist in young worker activities authorized by the representatives of the region on the Regional Youth Committee upon the recommendation of the National Director, subject to the approval of the National Executive Board.

The accumulated amounts are subject to a limit of \$40,000. Unused amounts exceeding \$40,000 shall be returned to the General Fund."

Sister Ray, Chair of the Constitution Committee, provided the rationale.

The Chair opened the floor for debate.

Brother Anthony Rogers, Nova Local, stated that composite resolution no. 2 to cover the intent of resolution nos. 21 and 72 was out of order as words were added which were not part of the original resolutions.

Brother Alain Robitaille, Constitution Committee member, provided the explanation that the resolution was written with text from the National Constitution.

The Chair ruled the composite resolution no.2, to cover the intent of resolution nos. 21 and 72, in order.

Sister Simpson, 1st National Vice-President, took the Chair.

Following further discussion, Brother Anthony Holzer, Fraser Valley West Local, stated that composite resolution no. 2 to cover the intent of resolution nos. 21 and 72 is out of order because it refers to the National Constitution and words were added which were not in resolution nos. 21 and 72.

The Chair ruled the composite resolution no. 2 out of order.

It is MOVED by Brother Robitaille, Constitution Committee member, SECONDED by Brother Ryan Spence, Constitution Committee member, to challenge the Chair.

Brother Palecek, National President, took the Chair.

Brother Robitaille and Sister Simpson presented their arguments.

The Chair asked the delegates if they were in favour or against the Chair's ruling. The delegates voted to sustain the Chair's ruling.

RESOLUTION NO. 61

WE WANT to establish a committee that will provide recommendations to the 2023 National Convention that will be voted on by the delegates at that convention. The committee shall review the National, Regional and Local structures, the officer and union representative positions and national committees. The committee shall use the March 6, 2010 report from the Independent Working Group on CUPW Structure as a starting point for its discussions.”

BE IT FINALLY RESOLVED that a tabloid detailing only the proposed changes included in the tentative agreement be sent to the entire membership.”

“The Committee unanimously recommends the adoption of resolution no. 201.

BE IT RESOLVED THAT CUPW lobby the authorities responsible for public roads to ensure road users are required to provide a safety corridor for Canada Post employees.”

Brother Rousseau, Chair of the General Resolutions and National Policies Committee, provided the rationale.

The Chair opened the floor for debate.

It is MOVED by Brother Trenton Garde, Nova Scotia Medical Communications Local, and SECONDED by Brother Jeff Callaghan, National Director, Atlantic Region and CARRIED to refer back resolution no. 201 to the Committee with instructions to change “Canada Post employees” to “CUPW members”.

Brother Rousseau, Chair of the General Resolutions and National Policies Committee, provided the rationale.

After debate, the question was called by Brother Benjamin Buxton, Napanee Local, SECONDED by Brother Hugh Irwin, Sault-Ste-Marie Local and CARRIED.

The Chair asked the delegates if they were in favour or against the adoption of resolution no. 201.

The delegates voted in favour of adopting resolution no. 201, as amended.

RESOLUTION NO. 208

Sister Jones, Secretary of the General Resolutions and National Policies Committee, read:

“The Committee unanimously recommends the adoption of resolution no. 208.

THEREFORE BE IT RESOLVED that CUPW shall work with Aboriginal/First Nations representatives to demand that the Provincial and Territorial Governments of Canada adopt and create policies and practices that honour “The Truth and Reconciliation Commission of Canada: Calls to Action.”;

BE IT FINALLY RESOLVED that CUPW shall work with Aboriginal/First Nations representatives to demand that the Provincial and Territorial Governments of Canada adopt and recognize the Federal Government of Canada’s statutory holiday which will be a National Day for Truth and Reconciliation.”

THEREFORE BE IT RESOLVED the following language be added to “C” as a new policy in the Policy section of the National Constitution:

OPPOSING SO CALLED RIGHT-TO-WORK LEGISLATION

The Union will actively lobby elected officials to stop all efforts to implement so-called right-to-work laws.

The Union will work in cooperation with organizations and coalitions who are opposed to so-called right-to-work laws.

The Union will develop a program of action to educate the membership, the public and elected officials about the realities, the real purpose and the adverse effects of so-called right-to-work laws.”

Brother Rousseau, Chair of the General Resolutions and National Policies Committee, provided the rationale.

The Chair opened the floor for debate.

Following debate, the question was called by Brother Kenneth Fong, Toronto Local, SECONDED by Brother Sarbjeet Deol, Toronto Local and CARRIED.

The Chair asked the delegates if they were in favour or against the adoption of resolution no. 212.

The delegates voted in favour of adopting resolution no. 212.

RESOLUTION NO. 188

Sister Jones, Secretary of the General Resolutions and National Policies Committee read:

“The Committee recommends the adoption of resolution no. 188.

THEREFORE BE IT RESOLVED that CUPW will take all necessary steps to contract in Combined Urban services work into our Urban collective agreement.

BE IT FURTHER RESOLVED that CUPW will demand that the CUPW members doing the Combined Urban service work are brought in to the Urban bargaining unit along with the work.”

Following debate, the Chair asked the delegates if they were in favour or against the adoption of resolution no. 191.

“The Committee unanimously recommends the adoption of resolution no. 195

THEREFORE BE IT RESOLVED that the Canadian Union of Postal Workers shall, in conjunction with the Canadian Labour Congress/FTQ develop a suite of short courses suitable for presentation in the context of a joint Labour Council CUPW Educational;

BE IT FURTHER RESOLVED that one of the courses be designed as an introduction to Unionism for allies and those workers who are not at the moment members of a Union.”

Brother Rousseau, Chair of the General Resolutions and National Policies Committee, provided the rationale.

Following debate, the Chair asked the delegates if they were in favour or against the adoption of resolution no. 195.

The delegates voted in favour of adopting resolution no. 195.

COMPOSITE RESOLUTION NO. 2 TO COVER THE INTENT OF RESOLUTIONS NOS. 220 AND 221

Sister Jones, Secretary of the General Resolutions and National Policies Committee, read:

“The Committee unanimously recommends the adoption of a composite resolution nos. 220 and 221.

THEREFORE BE IT RESOLVED that the Union (CUPW) will adopt when language permits gender neutral language at all levels of membership engagement;

BE IT FURTHER RESOLVED that the Union adopt when language permits a means of inclusion for transgender and gender variant individuals in documents, policy, letters and forms;

BE IT FURTHER RESOLVED that CUPW clarify positions reserved for women be open to all members identifying as women and that positions reserved for men be open to all members identifying as men;

New Policy D-47 Gender Neutral Language will read:

“CUPW recognizes that Transgender workers face discrimination in society, in the workplace and in the labour movement. CUPW knows that all people, regardless of their gender identity and / or gender expression, have a right to be treated with fairness, respect and dignity;

CUPW recognizes that the use of certain language such as Sister and Brother does not include Union members who are gender variant and/or who identify outside the female/male gender binary;

CUPW recognizes that language conveys powerful messages of inclusion and exclusion. CUPW is committed to building a Union that is inclusive of members who are gender variant and/or who identify outside the female/male gender binary. CUPW recognizes this means the Union must change when language permits the language used when referring to union members;

CUPW will adopt when language permits inclusive gender-neutral language to address union members, in order to be welcoming and inclusive of all of our members;

CUPW will also adopt when language permits gender neutral language when referring to union members, in all publications including but not limited to bulletins, letters forms, and the National Constitution;

CUPW will take steps to require that Employers of all CUPW bargaining units use when language permits gender neutral language in collective agreements and other documents and publications;

CUPW reaffirms its practice of ensuring that positions reserved for women be open to all members identifying as women and that positions reserved for men be open to all members identifying as men and that these positions also be open to those who are gender variant and/or who identify outside the female/male gender binary.”

Brother Rousseau, Chair of the General Resolutions and National Policies Committee, provided the rationale.

The Chair opened the floor for debate.

Following debate, the Chair asked the delegates if they were in favour or against the adoption of composite resolution no. 2 to cover the intent of resolution nos. 220 and 221.

The delegates voted in favour of adopting composite resolution no. 2.

RESOLUTION NO. 189

Sister Jones, Secretary of the General Resolutions and National Policies Committee, read:

“The Committee unanimously recommends the adoption of resolution no. 189.

THEREFORE, BE IT RESOLVED that the following language be added to National Policy A-11:

“The Union will promote the use of equal opportunity apprenticeships to fill vacancies in Groups 3 and 4.”

Policy A-11 will now read:

“The Union will work to eliminate sub post offices and other postal supplies distribution centres to replace them with postal stations and seek to organize the individuals who perform the functions of postal workers in such postal establishments.

The Union will take all necessary steps to have only members of the Union in good standing perform the jobs of the processing of all classes of mail, the sale of postage supplies, philatelic sales and setting of postage meters.

The Union will take all necessary steps to guarantee that the employer will not contract out any of the above services or accept for transmission by mail any class of mail that is processed by any other persons than members of the Union.

The Union will take all the necessary steps to guarantee that the employer will have the processing of mail, the sale of postage supplies in sub post offices and in semi-staff post offices, as well as the sale of philatelic supplies in private outlets performed only by members of the Union.

The Union will take all the necessary steps to ensure that only members of the Union will perform any of the duties of the bargaining unit under any circumstances.

The Union will take all the necessary steps to guarantee that the employer will not contract out any related work that is performed by Group 3 and Group 4 members of the Union.

The Union will take all the necessary steps to ensure that all maintenance-related work that is currently contracted elsewhere, be contracted within, so that Group 3 and Group 4 members perform all maintenance-related tasks in all postal establishments. The Union will promote the use of equal opportunity apprenticeships to fill vacancies in Groups 3 and 4.”

Brother Rousseau, Chair of the General Resolutions and National Policies Committee, provided the rationale.

The Chair opened the floor for debate.

Following debate, the Chair asked the delegates if they were in favour or against the adoption of resolution no. 189.

The delegates voted unanimously in favour of adopting resolution no. 189.

RESOLUTION NO. 244

Sister Jones, Secretary of the General Resolutions and National Policies Committee, read:

“The Committee unanimously recommends the adoption of resolution no. 244.

Encourage their members to write to their Premiers, MLA's and MP's to increase the staffing ratio in Long Term Care facilities across the country and ask CUPW Members to get involved in campaigns and activities organized to improve Long Term Care services.

BECAUSE the residents of Long-term care facilities are some of the most vulnerable people in our society.

BECAUSE many seniors and patients of long-term care facilities need better care.

BECAUSE the resident staff ratio has not seen an increase since early 2000.

BECAUSE 2.45 hours of care in a 24 hour period is not enough.

BECAUSE our seniors deserve better.”
