Proposed Amendments to the Elmwood Community Centre Board Agreement - A letter dated November 6, 2014 was forwarded by the Clerk to the Municipality of Brockton CAO requesting Brockton Council consider a proposed amendment to the Elmwood Community Centre Board Agreement that would permit the Board to carry its own insurance and hire its own bona fide auditor. The Brockton CAO responded by email on November 26, 2014 that there is only one Brockton Council meeting next month on December 22nd where regular business will be handled, and noted he is unsure if the new council will address this amendment request at this time or whether it will be deferred until January 2015. (Mayor Eccles indicated he will speak to the Brockton Mayor to encourage him to ensure this matter is placed on the December 22 Brockton Council meeting for discussion purposes.)

CAO/Deputy Clerk - Report #CR 12/15/14

Delegations for the 2014 OGRA/ROMA Convention (Council requested the CAO/Deputy Clerk request delegations for a joint delegation (Chatsworth/Grey Highlands/West Grey) regarding natural gas to rural areas; delegation to the Ministry of Education regarding proposed changes to the Accommodation Review Committee process; Ministry of Environment regarding Ontario Energy Board hearings, approval, and submissions process; Ministry of Transportation regarding the Highway 6 Connecting Link transfer, and Transportation Disability issues; Ministry of Health regarding the Chesley Hospital Rehabilitation Centre closure, with a possible joint delegation involving Arran-Elderslie and Brockton; and the Ministry of Environment regarding recycling costs.)

Request from MP Larry Miller - MP, Larry Miller, has requested a list of our top three priority infrastructure projects. Mr. Miller would then lobby on our behalf for Federal Funding support for these priorities on our behalf. I have spoken with Director of Public Works and Infrastructure Ken Gould and he suggests the following items as potential projects: broadband expansion into rural West Grey (\$22,500,000), several potential bridge replacements (\$6,000,000), sewer plant and SCADA system upgrades (\$4,800,000), connect the new well to the water system in Durham (\$865,000), various storm system upgrades (\$1,500,000), urban road cross-section rehabilitation (\$7,500,000), extension of natural gas into unserved areas (\$unknown) and water to Ayton via pipe from Neustadt, distribution system and standpipe (\$10,000,000). (Council requested the CAO/Deputy Clerk to inform M.P. Miller of the following three priority infrastructure projects: New Durham Well/Durham Sewer Plant and SCADA system upgrades - \$5.6 million; Extension of water to Ayton via pipe from Neustadt - \$10 million; and broadband expansion to rural areas of West Grey - \$22.5 million.)
